Ballot Proposition Recommendations

Vote "NO" on all PROPS

Abortion Rights

Abortion and contraception are already legal in California. Prop. I would enshrine a state constitutional right to an abortion up to the moment of birth at taxpayer expense. A shameless political tactic designed to drive leftist voters to the polls. Vote No.

Sports Betting at Tribal Casinos

Legalizes sports betting at American Indian gaming casinos and licensed racetracks. It requires tribal-state contracts to be renegotiated with the Governor and Legislature. A 10% tax rate on profits derived from gambling encourages corruption by creating a source of revenue for organizations who will donate to Democrats. Prop. 26 is a money grab. Vote No.

SEIU-UHW is back a third time with another dangerous dialysis proposition. Prop. 29 would mandate new staffing requirements and regulations for dialysis clinics. It would also raise the cost of dialysis providers, causing some of them to close – with potentially devastating consequences for patients. For a third time, Vote No.

This is a corporate money grab primarily funded by Lyft and disguised as a climate initiative.
